OpenCape Corporation

• Non-profit 501(c)3, Representative Board, Represents Interests of the Community

OpenCape Concept

- Develop the infrastructure of the 21st Century telecommunications
- Underpinning technology to economic development and civic engagement

OpenCape Funding (\$40 million)

- \$ 32 million ARRA BTOP
- \$ 5 million MA General Obligation Bonds through MTC/MBI Incentive Fund of 2008
- \$ 2 million CapeNet LLC, private Design, Build and Operate contractor
- \$750,000 Barnstable County Building Lease for Collocation Center
- \$ 300,000 Volunteer Time Donated

- 350 Mile Fiber Optic Network
- Microwave Public Safety Backup System
- Regional Collocation computer data center

Government Information Services

- Existing Model of Government Information Services
 - All Towns are Not the Same
 - Dispersed Digital and Analog Services
 - Towns, Schools, Libraries, and Public Safety
 - Cost
 - Lacks Economy of Scale
 - Little or No Aggregation
 - Isolated Networks
 - Multiple Support Staffs



Regional Government Services

- Regional Umbrella Services System (RUSS)
 - Infrastructure
 - OpenCape Municipal Regional Area Network
 - 1Gbps per town & 1Gbps aggregated Internet
 - Opencape Regional Collocation Center
 - 100sqft of floor space
 - Initial hardware for applications (VM SAN)
 - 3rd Floor RUSS Operations Center
 - Conference Room for County Complex Use

Applications

- Municipals/County (Regional GIS, E-Permitting, Assessor Databases)
- School Districts (Regional LMS, Data Center, Internet 2)
- Libraries (CLAMS library network and public access)
- Water Districts (shared applications, SCADA improvement)
- Public Safety
 - EOPSS/CJIS access
 - 700Mhz Mobile Public Safety Network
 - Regional Shelters and Intelligent Transportation
