Broad Categories of Eligible Uses for ARPA Funds (Source: US Treasury)

...For Barnstable County ARPA Funds

- 1. invest in water, sewer, or broadband infrastructure.
- 2. Fund public health system costs assoc. with COVID response, other health services, and related capital investment.
- 3. Address negative economic impacts of COVID on households, businesses, non-profits; disprop. impacted communities (includes housing and early ed./childeare).
- 4. Replace lost public sector revenue; Provide premium pay to employees providing essential work during COVID-19.

All funds have been appropriated by the BRC and AOD.



Application Review Process


ARPA Application Review Process

Levels 1 and 2 Review


CLA, and Powers & Sullivan/Marcum assess organizational / financial capacity to meet federal reporting standards, and project eligibility for ARPA funding.

• Level 3 Review


County staff review applications in accordance with **criteria** recommended by the Barnstable County ARPA Advisory Committee, and make funding recommendations to the Commissioners.

RFP Process— Housing Tranche (\$11.4M)

Housing Tranche—3 RFPs

Among the recommendations of the ARPA Advisory Committee was to allocate \$11.4M to housing-related priorities, as follows:

1.	Homelessness/Medical Respite	\$ 3,000,000
2.	Affordable Housing	\$ 6,900,000
3.	Workforce Housing	\$ 1,500,000
