Cape Cod Gateway Airport and Barnstable County to Hold Joint Community Meeting to Provide PFAS Mitigation Update

<u>Hyannis, Mass., October 31, 2024</u> – Cape Cod Gateway Airport and Barnstable County will host a joint meeting to provide the community with PFAS mitigation updates on Tuesday, November 12 at 5 p.m. at Barnstable Town Hall.

Per- and polyfluoroalkyl substances (PFAS) as a group of synthetic chemicals that have been in use since the 1940s. They are found in a wide array of consumer and industrial products, including stainand water-resistant coatings for fabrics and carpets, oil-resistant coating for paper products approved for food contact, mining and oil well surfactants, floor polishes, insecticide formulations and in Aqueous Film Forming Foam (AFFF), a firefighting foam commonly used to extinguish flammable liquid fires such as those caused by oil, gasoline, or jet fuel.

The Environmental Protection Agency (EPA) developed an Action Plan with an approach to identifying and understanding PFAS, approaches to addressing current PFAS contamination, and preventing future contamination.

In the Commonwealth of Massachusetts, the Massachusetts Department of Environmental Protection (MassDEP) Bureau of Waste Site Cleanup is tasked with ensuring the cleanup of oil and hazardous material releases pursuant to the Massachusetts Oil and Hazardous Material Release Prevention and Response Act (M.G.L. Chapter 21E). This law was implemented through regulations known as the Massachusetts Contingency Plan (310 CMR 40.0000 et seq. – the MCP). Both M.G.L. c 21E and the MCP require response actions to provide for the protection of harm to health, safety, public welfare, and the environment which may result from releases and/or threats of releases of oil and/or hazardous material (OHM) at disposal sites.

Both the Cape Cod Gateway Airport and the Barnstable County Former Municipal Fire Training Facility (MFTF) have disposal sites that require separate reporting and response to MassDEP per the MCP. Since varying types of firefighting foams were used at each site, and at varying frequencies, the environmental consultants for both the Airport and the County are tracing the source of contamination through a scientific "fingerprinting" process.

During the meeting, the airport and the County will each provide the community with an update regarding significant progress made toward investigating and mitigating PFAS resulting from releases at their respective sites.

"The Airport committed to providing annual community updates each November on the Airport's progress and status of mitigating PFAS at the Airport site," said Airport Manager Katie Servis. "Because the Airport is located directly downgradient of the Barnstable County Site, the Airport is working collaboratively with the County to distinguish each entity's nature and extent of PFAS so that both entities can provide concurrent updates to the community. This meeting is one of the first to be held jointly so that the public can be kept up to date on the efforts of both entities at one venue,"

The Former Municipal Fire Training Facility (MFTF) located at 155 South Flintrock Road Hyannis, served as a vital fire training location for the 15 towns of Cape Cod and associated fire districts from 1956 to 2013, where upon closure the use of PFAS foam was ceased in entirety. The site served as a training location for local fire chiefs and organizations to train staff to provide critical lifesaving services to all of Cape Cod.

The County is taking aggressive action to prevent further PFAS plume travel offsite. In addition to the groundwater treatment system onsite which is currently removing PFAS from the aquifer, the County is currently preparing to install a permeable reactive carbon barrier, which will serve to contain the plume and protect vital water supplies downgradient of the site.

"The County recognizes the need for aggressive action to control and remediate the PFAS plume emanating from the Former Municipal Fire Training Site. The County is actively coordinating with all stakeholders including the Town of Barnstable, Town of Yarmouth, Gateway Airport, Barnstable Water District, Hyannis Water Division, MassDEP, USGS and Tom Cambareri serving as a technical representative for the Cape Cod Sierra Club and Hyannis Civic Association. The large-scale coordination effort serves for a massive data and information sharing campaign and unified approach. The County is committed to delineating the extent and nature for the PFAS plume, and remediating the site through the best resources and technology available."

Cape Cod Gateway Airport, located on 639 acres in Hyannis, Massachusetts, provides commercial and general aviation services to New York, Philadelphia, Chicago, Boston, the islands of Martha's Vineyard and Nantucket and beyond.
